


### Terms and conditions:

- I. The above position is purely on a temporary basis and co-terminus with the project. The above age limits are relaxable for SC/ST and OBC candidates as per GoI Norms. Relevant documents need to be sent to the PI.
- II. There is no provision for absorption/ re-employment in ICAR/ICAR-CIPHET/after completion of time bound project. The service of appointed candidate will stand terminated automatically after expiry of the scheme/project or completion of period indicated in the selection offer, whichever is earlier.
- III. Place of work will be ICAR-CIPHET, Ludhiana, however, the candidate may be placed anywhere in India depending upon requirement of the project.
- IV. He / She will be full time worker and is required to adhere to the administrative, financial and disciplinary regulations of the Institute where the incumbent is working.
- V. No TA/DA will be paid for attending the interview.
- VI. The applicants must bring with them original documents and a brief of research work carried out during post-graduation / Ph.D. along with one set of photocopy of the certificates/ testimony at the time of interview.
- VII. No objection certificate from the employer in case he/she is already employed elsewhere.
- VIII. Experience certificate in original (if any).
- IX. No separate interview call will be issued to the candidates.
- X. The candidate however needs to inform the PI of the Project one month in advance, if he/ she wants to resign from the post, otherwise one month salary will be deducted / not paid to her/him.
