The service of appointed candidate will stand terminated automatically after expiry of the scheme/project or completion of period indicated in the selection offer, whichever is earlier.
- iii) Place of work will be ICAR-CIPHET, Ludhiana for research activities.
- iv) No TA / DA will be paid for attending the interview.
- v) The applicants must send the scanned documents and a brief of research work carried out during post-graduation / Ph.D.
- vi) No objection certificate from the employer in case he / she is employed elsewhere.
